KWQW "HOMEMAKERS FURNITURE-\$100 GIFT CARD" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station KWQW ("Station"), owned and operated by Cumulus Radio LLC 4143 109th St, Urbandale, IA, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KWQW** "HOMEMAKERS FURNITURE-\$100 GIFT CARD" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 3. **Contest Period.** The Contest will begin at **10:00 a.m., CT on July 21, 2018** and will run through **12:00 p.m., CT on July 21, 2018** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 4. **How to Enter.** To enter:
 - (ii) <u>Remote Broadcast</u>: Attend a remote broadcast conducted by that Station at Homemakers Furniture located at 10215 Douglas Ave, Urbandale, IA 50322 from 10:00 p.m., CT to 12:00 p.m., CT and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast.
- 5. **Winner Selection.** On or about 11:00 a.m., CT on July 21, 2018, Station will select one (1) entry in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
- 6. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a

liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. - Entry Conditions and Release. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
