98.3 THE VIBE'S "SHINEDOWN" TEXT CONTEST OFFICIAL RULES

Eligibility. - 3. How to Enter.
- 4. Text: Listen to the Station during the Contest Period. When the Station announces the Contest keyword, entrant must send a text message with the keyword spelled correctly to 515-252-0983 during the Contest Period. All entries must be received by 11:59 PM CT on December 1, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 5. Verification of Potential Winner.
