## 98.3 THE VIBE "TAYLOR SWIFT WRITE IT DOWN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KWQW ("Station"), 4143 109th Street, Urbandale, Iowa 50322, during available business hours Monday through Friday, on the Station website www.983thevibe.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **98.3 The Vibe's "Taylor Swift Write It Down"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the 30 days. Void where prohibited by law. Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest entry period will begin at 12:00 AM CT on Monday, April 10, 2023 and will run through 11:59 PM CT on Friday, May 12, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- **3.** How to Enter. There are two (2) ways to enter:

Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.
  - **B.** Online: Visit the Station's website <a href="www.983thevibe.com">www.983thevibe.com</a> during the Contest Period, click on the "Contest" link, click on the "Taylor Swift Write It Down" Contest link, and complete/submit the entry form.
  - C. All entries must be received by 11:59 PM CT on May 12, 2023 to be eligible for a chance to win a prize. Entrant represents and warrants that the entry (and accompanying photograph) is not indecent, lewd, offensive, defamatory, profane, or in bad taste and does not contain material that may infringe or violate any laws or anyone's rights.. Entry comments that are removed and/or blocked by Station, in its discretion, will be deemed not entered in the Contest. Limit one (1) entry per person per day, regardless of entry method or how many email addresses or mobile device numbers a person may possess and use. Multiple entrants are not permitted to share the same email address or mobile device number. Any attempt by any entrant to submit more than one (1) entry per day by using

multiple/different email addresses, mobile device numbers, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address or mobile device number used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address or mobile device numbers is submitted as part of this promotion. No mail-in or other entries will be accepted.

- **4. Winner Selection.** On or about 10:00 AM CT on Monday, May 15, 2023, Station will select One (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner may result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, is unable to accept the prize, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.
